Important Information

- All participants must be over 18 years old due to insurance reasons, and unfortunately, no exceptions can be made.
- Everyone must wear long pants that cover to the ankle without rips or tears, along with flat-bottomed, closed-toe, sturdy shoes with socks (no shorts, skirts, or capris). Hardhats, safety glasses, overcoats, and earplugs will be provided.
- The tour is anticipated to last 1.5 to 2 hours. To ensure punctuality, kindly arrive 10-15 minutes early for the sign-in process and to be fitted with personal protective equipment (PPE).
- The tour involves approximately 1.25 miles of walking, including ascending and descending several sets of stairs. Please ensure everyone can comfortably navigate this beforehand.
- Unfortunately, due to insurance constraints, the use of canes, walkers, or wheelchairs cannot be accommodated at this time.
- Bags or purses are not allowed inside the plant. Please leave these items in your car or check them in at our security office.
- Photography and video recording are not permitted during the tour.
- Visitors are required to present a valid picture ID during the sign-in process, so be sure to bring it with you.

Directions to Nucor Steel Seattle:

1. The plant address is 2424 SW Andover St. Seattle, WA 98106.
2. Travelling via West Seattle Bridge from I-5, take the Delridge Way SW exit.
3. Exit splits into two options, stay to the left and merge onto Delridge Way.
4. Turn right at the 1st stoplight (SW Andover St.).
5. Our driveway is 200 hundred feet down on the right after the intersection. At the Nucor sign turn right continue forward past the guard shack to the Large Nucor sign and gated entrance. Please Park in the visitor spaces at the entrance on the left. Follow the yellow pedestrian walkway to the tan building with the metal statue in front, this is where you will get your safety gear and a badge for entrance.

Antitrust Compliance

Antitrust law prohibits agreements or understandings between two or more individuals or businesses to regulate prices or quantities of goods and services, to allocate customers or territories, to hinder or limit a competitor or potential competitor's operations, or otherwise unreasonably restrain business activity. Discriminatory pricing or servicing is also prohibited.

Every individual who participates in AIST meetings and activities should follow these guidelines:

- DON'T discuss with other members your own or competitors' prices, pricing procedures, or anything that might affect prices such as costs, discounts, terms of sale, or profit margins, or anticipated wage rates.
- DON'T make announcements or statements about your own prices or those of competitors.
- DON'T talk about what individual companies plan to do in particular markets or with particular customers.
- DON'T disclose to others any competitively sensitive information.
- DON'T propose or agree to any action intended to disadvantage or injure another company.
- DON'T stay at a meeting or activity where any such anti-competitive talk occurs.
- DO have an AIST staff person present at any meetings and insist on the agenda being followed and minutes kept.
- DO confer with AIST staff before making any statement with competitive ramifications.

It is incumbent upon all AIST members to adhere to these guidelines to avoid putting all parties and their respective companies at risk for antitrust law violation.

Anti-Harassment Policy

The Association for Iron and Steel Technology (AIST) is dedicated to providing harassment-free events for everyone, regardless of age, race, religion, disability, gender, gender identity or sexual orientation. We do not tolerate harassment in any form of anyone attending an AIST event.
